DEED OF EASEMENT AND DEDICATION AND CONVEYANCE OF SEWAGE PUMPING SYSTEM

THIS DEED OF EASEMENT, made this 10TH day of SEPTEMBER 1996, by and between SHEARWATER CONDOMINIUM ASSOCIATION, ("Grantor" or "Association") and CITY OF ANNAPOLIS, a municipal corporation of the State of Maryland ("Grantee" or "City").

EXPLANATORY STATEMENT

The Association is the corporate body of the Council of Unit Owners of the Shearwater Condominium ("Condominium") and is charged with the administration of the Condominium and the community facilities consisting of parcels of land, buildings, improvements, rights, privileges and appurtenances thereto as authorized by the Shearwater Condominium Declaration dated December 29, 1981 and recorded among the Land Records of Anne Arundel County in Liber 3471 at folio 169.

The Association desires to dedicate and convey to the City all of its right, title and interest in and to the Shearwater Sewage gumping Station and Force Main (collectively referred to hereafter as the "Sewage Pumping System") and grant such easements to the City as necessary for the future access, maintenance, construction, reconstruction, repair and operation of the Sewage Pumping System.

The City has agreed to accept as of the date of this instrument this dedication and conveyance and to accept the responsibility for the maintenance, future construction, reconstruction, repair and operation of the Sewage Pumping System as part of the City's public sanitary sewer system, together with the necessary access easements. NO TRANSFER NECESSARY

As required by the Condominium Declaration and the Maryland Condominium Act, this dedication, conveyance and easement has been approved by Unit Owners having at least 66 2/3% of the votes and by the corresponding mortgages thereon.

NOW, THEREFORE, witnesseth, that for and in consideration of the Explanatory Statement, which is a material part of this Deed of Easement, and for other good and valuable consideration, the receipt of which is hereby acknowledged, Grantor hereby grants and conveys unto the Grantee, its successors and assigns, all of the Grantor's right, title and interest in and to the Sewage Pumping System within those areas designated and depicted as the "Utility Easement Area" on the plat which is attached hereto and designated Exhibit A. Grantee, on behalf of itself, its successors and assigns, accepts the Sewage Pumping System from the date of this instrument, and shall be solely responsible for the maintenance, construction, reconstruction, repair and operation of same and shall operate it as part of the City's public sanitary sewer system.

Grantor hereby grants to Grantee a perpetual easement in and to all those areas designated and depicted as "Utility Easement Area" on Exhibit A for the purposes of maintenance, construction, reconstruction, repair, modification, replacement and operation of the Sewage Pumping System, and the making of any temporary openings and excavations within such Utility Easement Area as are necessary and proper to effect such purposes.

Grantee covenants and agrees that any land of the Grantor disturbed by Grantee in the exercise of its rights under this instrument, either by way of excavation, openings or otherwise, shall be restored by Grantee promptly upon completion of work to at least as good a condition as existed prior to the disturbance.

Grantor grants and conveys unto the Grantee an easement of ingress and egress over the streets and ways of the Condominium for the purposes of carrying out and performing the duties and obligations with respect to the Sewage Pumping System.

This Deed of Easement shall run with and bind upon the land described herein, it being the intent of the Grantor and the Grantee Association that this instrument shall be a covenant running with the land; it being the further intent of the Grantor and Grantee that this Deed of Easement shall be binding upon their respective successors and assigns.




